SCHEDULING A SESSION/PAYMENTS: Upon scheduling an appointment a confirmation of the date and time along with pertinent forms that you need to complete will be sent to you via email. We do request a deposit upon scheduling your appointment – this verifies that you are indeed committed to yourself & your appointment. The deposit of at least 50% of the session cost is required to confirm your appointment (\$99.50 or if you wish you may pay full amount \$199) and must be received in our office prior to your session date unless previous arrangements have been arranged and approved. **Please note that we are unable to accept credit card payments at this time.** As most people now use online banking - We prefer email money transfers.
